- Mayor: Mayor Carney recently attended the Jonathan Alder School District strategic meeting with Mr. Hutchinson and Mr. Stanford. Additionally, the Mayor spoke at a luncheon with Jonathan Alder junior high students about what life was like in junior high when she and other local leaders were that age. Finally, the Mayor recently participated in a proclamation with the Union and Madison County Farm Bureaus to celebrate National Agriculture Week.
