A RESOLUTION ADOPTING THE VILLAGE OF PLAIN CITY PARKS AND RECREATION MASTER PLAN

WHEREAS, the Village of Plain City commissioned the creation of a Parks and Recreation master plan pursuant to the recommendations of the Village of Plain City Comprehensive Plan previously adopted by Village Council; and,

WHEREAS, the future provision of Parks and Recreational facilities and programming is important to the overall quality of life for the residents of Plain City and implementation of the plan's recommendations over time will help promote quality of life throughout the Village,

WHEREAS, the Parks and Recreation Committee has reviewed said plan at the direction of Village Council and recommends adoption of the plan as submitted by the Village's consultant; and,

WHEREAS, the Parks and Recreation master plan is detailed in Exhibit A attached hereto and incorporated herein.

NOW THEREFORE BE IT RESOLVED by the Village Council of Plain City, Ohio, as follows

Section 1. The Village Council of Plain City hereby approves the Parks and Recreation master plan as detailed by Exhibit A attached hereto and incorporated herein.

Section 2. The Village Administrator and Parks and Recreation Director are hereby directed to implement the recommendations contained in the plan for the betterment of the community. The Parks and Recreation Committee is hereby directed to work with the Village Administrator and Parks and Recreation Director to annually review implementation of the plan's recommendations and provide recommendations of future parks and recreation funding and plan amendments.

Section 3. The Planning and Zoning Commission is directed by Village Council to review the approved Parks and Recreation Committee master plan and consider its recommendations when reviewing future land development applications in Plain City for the future the provision of open space and recreational facilities.

Section 3. This Resolution shall be effective from and after the earliest period provided by law.
