Ordinance No. 8 - 2021

AN ORDINANCE AMENDING THE VILLAGE OF PLAIN CITY CODIFIED ORDINANCE CHAPTER 123 TO UPDATE THE CODIFIED ORDINANCE AND RESOLUTION PRACTICES AND PROCEDURES PURSUANT TO THE MUNICIPAL CHARTER PASSAGE.

WHEREAS, The electors of the Village of Plain City adopted the *Charter of Plain City, Ohio* at a Special Election on March 9, 2021; and

WHEREAS, "CHAPTER 123 Ordinances and Resolutions" of the Codified Ordinances of Plain City, Ohio is not currently compliant with the Charter of Plain City, Ohio; and

WHEREAS, The Council of the Village of Plain City desires to enact legislation to amend "CHAPTER 123 Ordinances and Resolutions" of the *Codified Ordinances of Plain City, Ohio* to bring it into compliance with the *Charter of Plain City, Ohio*; now, therefore, be it

ORDAINED by the Council of the Village of Plain City,

- 1. That CHAPTER 123 Section 123.01 POSTING OF ORDINANCES, RESOLUTIONS AND NOTICES is repealed.
