RESOLUTION NO. 17-2021

A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO APPLY FOR AN OHIO DEPARTMENT OF TRANSPORTATION PERMIT

WHEREAS, the Ohio Department of Transportation (ODOT) owns Parcel 39, as identified in the legal descriptions and exhibits provided to the Village, along Gray Street in Plain City, and

WHEREAS, the Village of Plain City currently provides for public roadway and utility service for an existing residential neighborhood in this area, and

WHEREAS, the Ohio Department of Transportation has directed the Village of Plain City to apply for a permit to allow pavement to remain in this area, and

WHEREAS, the Village Council has reviewed the plat and legal descriptions of the parcels, provided by the Ohio Department of Transportation, (Attached hereto as Exhibit A) and wishes to authorize the Administrator apply for a permit to maintain this permitted area;

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

- **Section 1.** The Village Administrator is hereby authorized and directed to apply for a permit from the Ohio Department of Transportation for right-of-way maintenance for the parcel in question.
- Section 2: The Permit Area Plat, attached hereto as Exhibit A, and incorporated by reference herein, is approved.
- Section 3: The administration of the Village, its administrator, engineer and zoning officer, and public works superintendent, will continue to be responsible for the future maintenance and upgrades to this area of public infrastructure.
