• Uptown Streetscape Update

- Updated version of street scape in packet from OHM, showing the new proposed street scape from Smith place around corner on N Chillicothe St. Wants to ensure that this meets what Council was looking for.
 - Mr. Terry asked about costs from original budget to this updated proposal.
 - Ms. Sonnett believes the original was \$350,000. Don't have the new costs.
 - Mr. Terry wants to know total impact on budget. Feels more economic to do it all at once but need to know if there is a supplemental, for decision making.
 - Mr. Reed will not support it if we are talking \$250,000 this year. Concerned with budget.
 - Mr. Terry believes it's a way to expend the CARES/ARPA dollars. And staying budge neutral.
 - Mr. Terry add breakdown of costs to work session in September.

Citizen Recognition Program

Mr. Terry said we have a petition. How does it look? Where would it fit? Maintain our ascetics where we aren't the "home of ten" individuals, and set a precedent and carve out a space to hang the plaques, like in the park.

Mr. Reed think it's good to have a policy.

Mr. Terry we have a policy. Our duty is to determine how we recognize.

- Mr. Rucker would like it someplace visible, not the park.

- Mr. Terry make administration responsible to provide solution for Council to vote on .

- Mr. Terry thinks we are already giving that. Visible, scalable, clean
- Ms. Sonnett will have Linda Granger give options for Council to decide.
- Mr. Reed asked about small green area just west of McKitrick Park.
