DRB Appeal Hearing: Certificate of Appropriateness - COA-22-11

- Mr. La Fayette explained hearing process. Mr. Rucker will abstain from participating in the proceeding as he is a member of the DRB. Will create a finding of fact for future meeting. Mr. Terry recommended schedule this for Work Session on November 2, 2022. Mr. La Fayette advised all participants can attend the Work Session but there will not be further discussion from the parties.

 - Owner 138 W Main St

 - Member of DRB board in Plain City and Kenton (Harden County)
 - Discussed attendance at DRB meetings of June 29 and July 27, 2022
 - Feels this is going to detrimentally affect his business
 - Has never seen anything of this scale be approved by DRB

 - Described alley looking south from the back of his property
 - Discussed direction of stairs on his building, for about 1.5 years, as a result of meeting fire emergency exit code
 - Had a gentlemen's agreement with Mr. Houchard, Mr. Jason James, and Mr. Ralph Smucker affected by the alley and didn't want to impede or prevent anyone from getting to the back of that alleyway. Approached and petitioned Council to abandon that alley because it did not serve a public purpose. There are overhead electric lines, underground gas, sanitation and water lines.
