Ordinance 12-22, An Ordinance Amending Ordinance No. 19-20, Passed on November 23, 2020, To Revise the Development Text And Preliminary Development Plan for the Darby Station Residential Development.

Mr. La Fayette swore in testimonials

Josh Barkin, MI Homes, development of Darby Station going well. About half way thru construction of traffic circle. Minor amendment to zoning plan, density neutral, empty nester is struggling in filling homes. Allowing 2 story homes mixed into this area would better be able to serve the market.

Mr. Reed asked about condo area and private road, village not responsible for road, condo association will contract for trash services. Fire hydrants and water lines will be private and HOA will flush hydrants. Mr. Barkin confirmed everything.

Mr. Yoder addressed roundabout, does not permit farm machinery to get through the double lane.

Close public hearing.

Mr. Terry going from block to cul-de-sac layout is more aesthetic looking.

Mr. Eudaily asked about on-site parking. Ms. Brill responded that every unit will be required to have required parking.

Mr. Reed discussed speed limit. Parking rule will be up to condo association to decide rather than the village. Mr. Barkin they will be subject to zoning plan. If not in zoning text, then they make their own rules, per Mr. La Fayette.

Mr. Yoder asked question about Butler area subarea road.
