Ordinance No. 3-22

AN ORDINANCE APPROVING A SUPPLEMENTAL APPROPRIATION OF FUNDS AND AMENDMENTS TO THE VILLAGE OF PLAIN CITY 2022 BUDGET.

WHEREAS, it is incumbent upon the Council to provide appropriations for the current expenses and other expenditures of the Village; and

WHEREAS, the Village previously passed an operating and capital improvement budget for 2022 based on estimated revenues and expenses for 2021; and

WHEREAS, the Village desires to amend the previously approved annual appropriation of funds and 2022 budget in order to provide adequate funding for certain projects and programs identified by the Village as detailed in Exhibit "A" attached hereto and incorporated by reference herein; and

WHEREAS, the Village Council has determined that the appropriations are appropriate and necessary to ensure the proper operation of the Village and make necessary capital improvement investments in the community.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

- **Section 1.** That the sum of <u>33</u> Million, <u>143</u> Thousand, <u>198</u> Dollars and <u>37</u> Cents (\$33,143,198.37) is necessary to be appropriated to meet the fiscal obligations of the Village of Plain City for fiscal year 2022 and such sums are hereby set aside and appropriated in accordance with the attached operating and capital improvement plan budgets referenced as Exhibit "A" attached hereto and incorporated by reference herein.
- **Section 2.** That the Village Finance Director is hereby authorized and directed to make such appropriations and distribute funds in accordance with Section 1 above.
- Section 3. This Ordinance shall replace Resolution 45-2021, which previously determined final appropriations for current expenses of the Village through December 31, 2022.
- **Section 3.** This Ordinance shall be effective from and after the earliest period provided by law.
