WHEREAS, Village Council wishes to commence the public bidding process for said project.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Plain City, Ohio, a majority of the members elected or appointed thereto concurring, as follows:

- Section 1. The Village Administrator is hereby authorized and directed to advertise and accept bids for the Villa Drive Water Main Replacement Project pursuant to Ohio Revised Code Section 735.05.
- Upon receiving and opening bids for said project, the Village Administrator shall present a recommendation as to whether to award a contract in connection with the public bidding process. Award of a contract for the project shall be authorized by action of Village Council in accordance with the Ohio Revised Code.
- Section 3. Effective Date. This ordinance shall be in full force and effect from and after the earliest period provided by law.
