ORDINANCE NO. 15.20

AN ORDINANCE AMENDING VILLAGE ORDINANCE 123.01 TO AMEND LOCATIONS FOR POSTING OF ORDINANCES, RESOLUTIONS AND NOTICES.

WHEREAS Village Ordinance 123.01, addressing the posting of ordinances, resolutions and notices to the public, was last amended through Ordinance 26-04 on October 11, 2004;

WHEREAS the Village Council has reviewed and determined that some locations offered for posting of ordinances, resolutions and notices will no longer be accessible by the general public;

WHEREAS the Village Council has determined that Ordinance 123.01 requires amendment to ensure the availability of such postings for the public; and,

WHEREAS Village Council proposes the amendments as set forth on attached Exhibit A.

NOW THEREFORE BE IT ORDAINED by the Village Council of Plain City, Ohio, as follows:

Section 1. The Village Council of Plain City hereby adopts the amendments to Ordinance 123.01, listing the places of posting ordinances, resolutions, and notices, as follows:

- 123.01(a) the Village of Plain City Municipal Offices located at 800 Village Boulevard;
- 123.01(b) the Plain City School District Public Library located at 305 W. Main Street;
- 123.01(c) shall be amended to provide for posting at Middlefield Bank;
- 123.01 (d) the Richwood Banking Co. located at 601 W. Main Street; and
- 123.01(e) the Village website.

Section 2. The Village Council of Plain City hereby authorizes the Fiscal Officer to order the changes to the Codified Ordinances of the Village of Plain City in accordance with this Ordinance.
