## RESOLUTION NO. 16-2022

## A RESOLUTION APPROVING RENEWAL OF CONTRACT FOR THE COLLECTION OF RESIDENTIAL WASTE AND GARBAGE, WITH RECYCLING

WHEREAS, Resolution 38-19, passed on December 9, 2019, authorized the competitive bidding of the collection of residential waste and garbage with recycling services;

WHEREAS, the Village administrator received two bids in response to the bid package that was issued and Council determined that the lowest best bidder is Local Waste Services; and,

WHEREAS, on December 9, 2019, pursuant to authorization of Council, the Village entered into a contract with Local Waste Services for Residential Refuse and Garbage Collection, with recycling, for a three (3) year term (2020, 2021 and 2022) at a cost of \$17.49 per customer/resident (attached as Exhibit A); and,

WHEREAS, the December 9, 2019 contract with Local Waste Services provided for an optional extension, upon mutual agreement of the parties, for an additional three (3) year term (2023, 2024 and 2025). The cost for the extension is premised upon the \$19.95 base price of the 2019 contract plus a one-time increase based upon the Consumer Price Index as determined by the Federal Bureau of Labor and Statistics; and,

WHEREAS, the Village Administrator has reported that Local Waste Services has provided service as required under the 2019 contract and that the services have met the expectations of the Village and its residents; and,

WHEREAS, Council deems it appropriate to exercise the option to extend the Residential Refuse and Garbage Collection, with recycling, with Local Waste Services for an additional three (3) year term and authorize the Village Administrator to execute the contract for the extension of services for the years 2023, 2024 and 2025.

NOW THEREFORE BE IT RESOLVED by the Village Council of Plain City, Ohio, as follows:

**Section 1.** The Village Council of Plain City hereby exercises the three (3) year extension of the contract for the collection of residential waste and garbage, with recycling, with Local Waste Services for the years 2023, 2024 and 2025.

Section 2. The Village Council of Plain City hereby authorizes the Village Administrator to enter into a three (3) year extension of the 2019 contract with Local Waste Services for the collection of residential waste and garbage, with recycling for the years 2023, 2024 and 2025.
