WTTP/Permit Discussion

- Mr. Terry said there were questions from the last meeting. We are definitely not anywhere near 3 million permit; we are closer to 1 million permit. Our plant will be built to that 1 million. I think there are times when we have heavy water items but EPA is well aware of it. Wants the questions answered now. We are well within our limits and doesn't want it to come into question in the future.
- Mr. Reed said it does peak at 3.5 million on certain days. Is a concern that we will shortly be over the 1 million gallons a day. The solicitor says the EPA watches our capacity. If were going to spend the \$10 million whether we should be going 1 or 1.5.
- Mr. Terry our permit is 1.5 million gallons per day, capacity of the plant is for 1.0.
 Untreated is a dangerous word, less treated goes through the aquafers quicker. On the PTI vs average usage, the significant amount of current flow a new home with a separate water/sewer system will not go in as our older homes. It's not a 1 on 1 basis.
 EPA is looking at our average. Plus, we are upgrading the current facilities to enhance our ability to treat the about of water that is currently flowing through.
- Mr. Reed, adding 1800 homes its not hard to imagine that we are going to be over 1 million. EPA looks at capacity not what the permit says.
- Mr. Terry, EPA receives our data on a regular basis. If there was a concern, the EPA would not allow us to go through this process. Confident that we are well within our compliance. Of course we know that this isn't a long term answer and that's why we are proceeding with the 6119.

Zoning Code Update

- Received most updated Zoning Code draft. Will publish by Wednesday that gives time for review by the public ahead of the public hearing on the 14th
- Mayor Carney wants a slat sign for public hearing
- Ms. Brill, we have yard signs and will post on the app
